**SAFETY, BEHAVIOR and LIABILITY**

**The safety of the dog** is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.

**It is expressly understood** that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. The GLASWC and its agents, employees, etc., will assume no responsibilities for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children. The GLASWC reserves the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against the GLASWC or any official thereof.

**All dogs must be on leash** at all times when on trial grounds except when in the designated warm-up area or competing on the course.

**This club does not agree to arbitration as stated on the AKC Entry Form.**

**REFUNDS**

**No refunds will be given for overpayment of \$6.00 or less.**

**No entry fee will be refunded** if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, a public emergency, act of a public enemy, weather or any other cause beyond the control of the organizing committee.

**No entry fee will be refunded** in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee.

**If an entry was made online**, no refund of the service fee will be refunded for any reason.

**Refunds for injured dogs or handlers:** 50% refunds will be given for a dog or handler that has a note from their veterinarian or doctor saying they cannot participate in the show. The doctor's appointment must have been before the show.

**Full Entry fees** will be refunded if an entry is pulled before the closing date/ time. **However, online convenience fees will not be refunded for any reason.**

**Bitches in season** are not permitted to compete in Agility Trials. Bitches in season are not allowed on the show grounds. As such, the club will issue full refund minus \$5.00 processing fee for bitches unable to compete for this reason if the **Trial Secretary receives WRITTEN notice of withdrawal no later than 30 minutes prior to the start of the first class.**

**Change of judge:** If the judging assignment changes after the distribution of the premium list, an exhibitor has the right to request a full refund of their entry fees for any class affected. Exhibitors must submit requests in writing to the Trial Secretary a minimum of 30 minutes preceding the start of the event on the first day the exhibitor is entered.

**Illegible entries** will not be processed and will be returned to the exhibitor. Returned checks do not constitute a valid entry and the Trial Secretary will add a 20.00 collection fee (optional) to the amount of each returned check.

### GENERAL TEST REQUIREMENTS

Non-competitive pass/fail evaluation of dog's ability to exhibit self-control in a rural farm setting.

Open to all dogs at least 9 months of age that are individually registered with the AKC, recorded in the FSS program, dogs with PAL numbers, or dogs enrolled in the AKC Canine Partners Program. Females in season may not enter.

Safety is paramount. Farm site must be well maintained, with fences, gates and equipment in good working order. All livestock must be in good condition, provided with fresh water, clean housing, and confined to dog proof enclosures during the test evaluation.

The Judge must have at least one assistant to aid in administering the test.

Dogs must be always on a leash while on farm site unless confined in a crate, kennel or vehicle. The leash shall be four to six feet in length.

Dogs must wear a secure, well fitting, flat collar during the test evaluation.

Handlers can use verbal cues, hand signals and praise provided it is not excessive in the opinion of the Judge.

Dogs may attempt each test element no more than two times.

Dog must pass all elements of the test and overall assessment during the same test to qualify.

Dog must qualify under two different Judges in order to qualify to be awarded the FDC suffix title.

The Judge may discontinue testing if he/she determines the dog is too fearful or under duress to perform the required elements.

The Judge may request the removal of any dog from the immediate test area at any time, if he/she determines the presence of the dog presents a risk to livestock, other dogs, or persons on farm.

**AGREEMENT**

I certify that I am the actual owner of the dog, or that I am the duly authorized agent of the actual owner whose name I have entered. In consideration of the acceptance of this entry, I (we) agree to abide by the rules and regulations of The American Kennel Club in effect at the time of this event, and any additional rules and regulations appearing in the premium list of this event and entry form and any decision made in accord with them. I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. I (we) certify and represent that the dog entered is not a hazard to persons or other dogs. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog. **INSTRUCTIONS**

Handlers may opt to enter in a higher **height division** for all **Regular** titling classes, but not in a division lower than their proper height division. Dogs entered in the **Preferred** classes **must** compete at the required jump height and **may not** compete in a jump height division **higher or lower** than their proper height division.

All dogs that have not been officially measured for an **Agility Jump Height Card** may still compete; however, they must be measured by a Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. If measured by the Judge of record, that measurement will be valid for this trial *or back-to-back trials* only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.

Dogs listed in the **AKC Canine Partners<sup>SM</sup>** program may be eligible to enter all-breed AKC agility trials at the club's option. These dogs should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.

**Junior Handlers** should enter their Junior Handler number on the front of this form. Should you not have your Junior Handler number, it may be obtained from the American Kennel Club (919) 233-9767. If the Junior Handler is not the owner of the dog identified on the face of this form, what is the relationship of the Junior Handler to the Owner?
